Formulate Topic and/or Thesis

Your article must be in a format which would be fit for a magazine or newspaper. Therefore, it *must have a title, be written in column form, and contain pictures*. Your article should be exactly one, two, or three pages, including several of the following attributes:

Subject Headings Scenarios
Supporting Statistics Quotes
References

Any picture or graph used in your article must be referenced.
